

RES-Q UPDATE MAY 2017

ESOC EDITION

With the rapid approach of the 2017 European Stroke Organization Conference (ESOC) in Prague, we wanted to take this opportunity to provide an update on the progress of RES-Q.

It has been a busy time for RES-Q with the first official data collection period ending at the beginning of April. We would like to thank everyone for their participation, and for your ongoing contributions to improving the RES-Q registry.

We are currently in the process of finalizing the data aggregation for the March collection period and will have results available soon.

1 REQUESTS FOR DATA BEFORE ESOC

For anyone wishing to present their country's data at ESOC, we would ask that you send us a request for your data before the end of this week (Friday, May 5th).

A few points about the data:

- ✦ We can provide your RES-Q data to you in either just the **raw form**, or as the **raw data plus descriptive statistical analysis** (please see the attached Supplement document with a complete list of the descriptive statistical analysis outcomes, as well as a few sample anonymized graphs).
- ✦ Raw data can be sent in .csv, SPSS, or .txt formats; please specify which format you need.
- ✦ If you have any special requests regarding the delivery or processing of the data, please include them with the data request.
- ✦ Send the request to admin@qualityregistry.eu **no later than Friday, May 5th**.
- ✦ Requests made later than Friday, May 5th will automatically **only** be eligible to receive the raw data.

2 GENERAL REQUESTS FOR DATA

For data that isn't specifically needed for ESOC, these requests can be sent at any time, after ESOC.

- The request should be sent by the country representative, or the local coordinator, and should be addressed to admin@qualityregistry.eu. Country representatives have access to all the data in their country, while the local coordinator can receive only data from their centre.
- The current expected delivery time for raw data (data without analysis) is 1 business day, and 3 days for raw data with descriptive statistical analysis, as outlined in the Supplement.
- Please state in your email if your request is urgent, and we will try to prioritize, however requests prior to ESOC will need to be handled as outlined above.

We are working to add an additional user role to the registry that will allow authorized users to download their own data, however until this role is available, this is how we will help get your data to you.

3 ENTERING DATA FOR MARCH

The first official data entry period concluded at the beginning of April this year, so we encourage all sites to enter their patients for the month of March as soon as possible.

Please remember to mark patients as complete when you are done entering data.

Even if the data entry is not completed in time to be presented at ESOC, it is still important to enter it as it will be included in future reports.

4 PROMOTING YOUR EVENTS

In order to help support your participation in RES-Q, and to make the RES-Q website more useful and informative for everyone, we would like to offer the RES-Q webpage and events calendar as a way to publicize events in your country.

Please send any upcoming events or updates regarding RES-Q, or stroke care, to admin@qualityregistry.eu and we will publish them on the RES-Q website.

5 ESO ANGELS AWARDS

ESOC will mark the beginning of a new initiative for RES-Q. In collaboration with ESO and SITS, RES-Q will be part of the ESO Angels Awards program.

The ESO Angels Awards will recognize hospitals and stroke treatment centres for excellence in stroke care quality. For centres that wish to apply for ESO Angels Awards, a combination of data contributed to RES-Q and SITS can be submitted to the ESO Angels Awards committee.

More information regarding the ESO Angels Awards, including data requirements, and award levels will be made available at ESOC.

6 PLATFORM DEVELOPMENT

In order to allow time for data compilation prior to ESOC, we have temporarily postponed deployment of the monitor user role. We are still actively working on implementing this role to provide more granular data access, and we hope to make it available very soon.

We are also continuing to add more translations for the site to make it accessible to more users, if you have a translation, or would like to contribute a translation for your country, please contact us at admin@qualityregistry.eu.

Finally, we are always looking to improve RES-Q, so please continue sending all of your feedback, comments, and any bugs you find. We greatly appreciate any input you have that can help make RES-Q better for you.
